

Privacy Policy

Aston Baltic values the privacy of its customers and observes due care in processing and protecting personal data.

We collect only the personal information provided voluntarily by visitors to our web sites so that we can offer information or services to those individuals or offer information about employment opportunities.

Privacy-sensitive and personal data are processed through our website, and during processing we comply with the requirements of the applicable data protection legislation. This means we:

- Clearly specify our purposes before we process personal data, by using this Privacy Statement.
- Limit our collection of personal data to only the personal data needed for legitimate purposes.
- First ask for explicit permission to process your personal data in cases where your permission is required.
- Take appropriate security measures to protect your personal data and demand the same from parties who process personal data on our behalf.
- Respect your right to inspect, correct or delete your personal data held by us.

Aston Baltic is the controller for all data processing. In this privacy statement, we will explain which personal data we collect and for which purposes. We recommend that you read it carefully.

Use of Personal Data

By using our website, you are providing certain data to us. This could be personal data. We only retain and use personal data that has either been provided directly by you or that has clearly been supplied to us to be processed.

We use your name and email address for the purposes mentioned in this privacy statement. Other than advertisements on our website, we can inform you about new products or services through our Web pages in social networks.

We do not share personal information with unaffiliated third parties, except as necessary for our legitimate professional and business needs, to carry out your requests, and/or as required or permitted by law or professional standards.

Aston Baltic may also disclose Personal Information in connection with the sale, assignment, or other transfer of the business of the site to which the data relates, in order to respond to requests of government or law enforcement agencies or where this is required by applicable laws, court orders, or government regulations. These disclosures may also be needed for data privacy or security audits and/or to investigate or respond to a complaint or security threat. Aston Baltic does not sell Personal Information to any third parties. Also, AstonBaltic will not transfer the Personal Information you provide to any third parties for their own direct marketing use.

Retention Periods
